INTRODUCTION ABOUT FTU

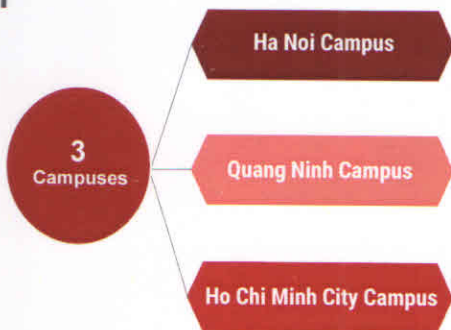

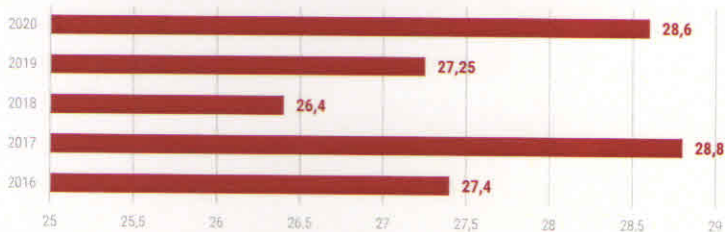
1. GEOGRAPHIC FOOTPRINT

HOW TO APPLY

1. ENROLLMENT REQUIREMENTS

Students are eligible to apply for Foreign Trade University undergraduate programs if they can meet the following requirements:

- A recognized high school diploma with average score of minimum 7.0/10.0 (10-point scale)
- Vietnamese language certificate level 4/6 (6-level scale) for applicants of programs taught in Vietnamese.
- Academic IELTS 5.5 certificate or equivalent for applicants of programs taught in English.
