#### **About The Workshop**

The Capacity Building Workshop is organized by the "Scientific Research Center of Historical and Cultural Heritage" SNCO of the Ministry of Education, Science, Culture and Sports of the Republic of Armenia within the framework of the grant allowed through the Intergovernmental Body Allocation Contract between UNESCO and the "Scientific Research Center of Historical and Cultural Heritage" SNCO. The aim of the workshop is to summarize the scientific research works carried out in 2022 in the area of monuments inscribed in the UNESCO World Heritage List – Monasteries of Haghpat and Sanahin; Monastery of Geghard and Upper Azat Valley, Cathedral and Churches of Echmiatsin and the Archaeological Site of Zvartnots. Both national and international specialists and experts are involved in works.

Historical-architectural researche works of Archeological sites of Zvartnots, Mother See of Holy Etchmiadzin (including St. Hripsime Church, St. Gayane Church, St. Shoghakat Church), Geghard, Haghpat and Sanahin monastic complex areas are currently being implemented, the archives have been revealed, historical references have been compiled, 3D scanning of the mentioned sanctuaries and other necessary works were almost done.

The workshop will be followed by the stages of processing and analysing the collected data, as a result of which a complete plan of the mentioned monuments' conservation, management and risk preparedness will be done in order to provide to all interested parties and to take appropriate action.

The final results of the workshop are addressed to all stakeholders concerned, including the representatives of the Armenian Church.
