

## **MEMORANDUM**

**BETWEEN THE MINISTRY OF EDUCATION, SCIENCE, CULTURE AND SPORTS OF THE

The Ministry of Education, Science, Culture and Sports of the Republic of Armenia, the Standing Committee on Science, Education, Culture, Diaspora, Youth and Sports of the National Assembly of the Republic of Armenia, “National Cinema Center of Armenia” state non-profit organization and the “PEOPLE OF AR” limited liability company, hereinafter referred to as the Parties,

- emphasizing the development of film production through the development of the film industry in Armenia,
- the international potential of the film industry and the importance of film production by foreign filmmakers in Armenia.

RESOLVED to sign this Memorandum to the following effect:

### **Article 1**

The parties will make efforts to implement joint film production and develop film production in Armenia.

### **Article 2**

The Government bodies of the Republic of Armenia, as parties to this memorandum will support the process of providing a partial cash rebate of the investments of Til Schweiger's

films "Underdog", "Dead by Dawn", "Collapse"/Part 8, in accordance with the relevant articles of the Law "On Cinematography" of the Republic of Armenia.

### **Article 3**

Students of creative universities of Armenia will be involved in the process of shooting the film, affording them with the opportunity to be in a real film production area, to acquire professional skills and abilities.

### **Article 4**

The Parties will contribute to the involvement of specialists in shooting of internationally renowned films and will promote cooperation with reputable specialists of international scale.

### **Article 5**

The cooperation of the Parties will make it possible to ensure the proper positioning of Armenia on the international film platforms, from now on also as a country with a partial cash rebate system, which will stimulate the investments of foreign filmmakers in the Armenian economy, providing new investments in the film industry sector.

### **Article 6**

The Parties will also cooperate in the development of sub legislative acts and implementing reforms in the field.

### **Article 7**

The "PEOPLE OF AR" limited liability company, jointly with "National Cinema Center of Armenia" state non-profit organization will make efforts to invite international filmmakers to the Republic of Armenia and implement their audiovisual production in Armenia.

### **Article 8**

This Memorandum enters into force on the date of its signing and remains valid until completion of the relevant obligations by the sides.

This Memorandum signed on "18" december 2023 in the city of Yerevan in 4 (four) original copies, each in Armenian and English, all texts being equally authentic.

In case of divergence of interpretation of the provisions of this Memorandum, the armenian text shall prevail.


